

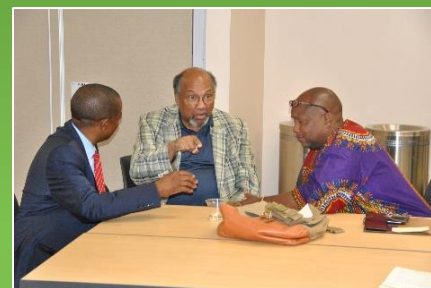


## Using Trade, Investment and Economic Development for Peace & Conflict Resolution Sacramento, California April 26 - 30, 2023
